# 2 Section II - Instructions to Bidders

#### 2.1 Part I - General

#### 2.1.1 Definitions

- 1. "Bid" means the bidders response to technical and commercial requirements as stated in this RFP document.
- 2. "Bidder" means any entity that may provide or provides the Services to the TRTI under the Contract.
- 3. "Instructions to Bidders" (Section II of the RFP) means the document which provides interested Bidders with information required to prepare their bids. This document also details out the eligibility criteria and process for the selection of the Service Provider. Bidders are encouraged to contact TRTI, conduct necessary fact finding for any further details, by themselves at their end.
- 4. "Service Provider" means the Bidder/s that has been selected by the TRTI for execution of the services.
- 5. "Scope of Work" (SoW) explains the objectives, scope of work, activities, tasks to be performed and the respective responsibilities of the Purchaser and the Service Provider. It also includes the Service Level Agreement (SLA). A complete elaboration is available in Section III of the RFP.
- 6. "Standard Contract" means the Annexure-III of the RFP which provides the standard contract agreement to be signed between the Purchaser and the selected Service Provider.
- 7. "Confidential Information" means any information disclosed to or by any Party to this Contract and includes any information in relation to the Parties, a third party including any such information that may come to the knowledge of the Parties hereto/Bidder's team by virtue of this Contract that is by its nature confidential or by the circumstances in which it is disclosed confidential and/or is designated by the disclosing Party as confidential or identified in terms connoting its confidentiality; but does not include information which is or becomes public knowledge other than by a breach of this Contract.
- 8."Sub-Contractor" means any person or persons or firm/company or their legal representatives, successors, assignees to which part of contract has been sublet by the successful bidder after necessary consent of TRTI.

# 2.1.2 Procedure for Submission of Bids

The Bid should be submitted on online https://mahatenders.gov.in/ Portal only.

### 2.1.3 General

- 1. All the provisions listed out in the Request for Proposal (RFP) issued by the TRTI shall be binding upon the participating bidders of this RFP.
- 2. TRTI will select Service Providers, in accordance with the method of selection as detailed in Part-IV of Section-II "Selection Process".

3. The detailed scope of the assignment/job has been described in the Scope of Work in Section III of RFP.

- 4. The date, time and address for submission of the bid have been given in RFP.
- 5. Interested Bidders are invited to submit the documents for Technical Bid and Financial Bid, strictly as per Part V of Section II – "Instructions on Bid Preparation and document checklist".
- 6. TRTI is not bound to accept any or all the bids, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Bidders and assigning any reason to the bidder.

# 2.1.3.1 Only One Bid

A Bidder shall submit only one Financial/Commercial Bid. If a Bidder submits or participates in more than one bid, such bids shall be disqualified.

# 2.1.3.2 Bid Validity

The Part II of Section-II indicates the period for which the Bidders' Bid valid after the submission date.

# 2.1.3.3 Consortium and Sub-Contracting

Bids received from Consortiums will be rejected. Sub-contracting of any work resulting from the tender is not allowed except with the prior approval of TRTI.

# 2.1.3.4 Tenure of Contract

- 1. The tenure of the Contract shall be as specified in 'Data Sheet' at Part-II of Section-II.
- 2. Extension of the contract: The contract may be extended as specified in 'Data Sheet' at Par-II of Section-II.
- 3. Termination of the contract: Notwithstanding the allocation of the volume of work during the Contract period and/or tenure of Contract, the TRTI reserves the right to terminate the contract without prejudice or liability after giving notice as stipulated in GC and SC.

# 2.1.4 Clarification and Amendment of RFP Document

- 1. Bidders may request a clarification in the RFP document up to the number of days indicated in 'Data Sheet', before the bid submission date. Any request for clarification must be sent to the official email id <u>trti.mah@nic.in</u>. Clarifications to the query mails shall be listed on the website while queries raised in the pre-bid meeting shall be addressed specifically to the concerned party via an email.
- 2. At any time, before the submission of Bids, TRTI may amend the RFP by issuing an addendum/corrigendum in publishing on TRTI website. The addendum/corrigendum shall be made available on <a href="https://mahatenders.gov.in/">https://mahatenders.gov.in/</a> as well as TRTI's Portal and shall form a part of the RFP.

# 2.1.5 Preparation of Financial Bid

- 1. The preparation of the Financial Bid as well as all related correspondence exchanged by the Bidders and the Purchaser shall be in English.
- 2. The Financial Bid shall be prepared using the attached Standard Form as in Annexure-I and Annexure-II. It shall include all costs associated with the Service/Assignment.

The financial bid shall not include any conditions attached to it. Any such conditional financial bid shall be summarily rejected.

#### 2.1.6 Taxes

- 1. As part of tax payments only the applicable GST shall be paid by TRTI to the selected service provider on completion of the work and all other taxes, levies, duties etc. shall be borne by the service provider at its own cost. Bidders shall mention all such taxes in quoted cost in the financial bid separately as per the format provided.
- 2. Bidders shall provide the price of their services in Indian Rupees (₹) and up to two decimal places only (for example: Rs ------ oo.oo) (exclusive of taxes)
- 3. The service provider shall be entirely responsible for all taxes, duties, octroi, license fees, and demurrage charges etc. (except GST), incurred on the contracted Services to the Purchaser. Bidder shall provide the cost of the services and all applicable taxes separately as per the format provided in the RFP.

# 2.1.7 Earnest Money Deposit (EMD)

- 1.An EMD in the form of a Bank Guarantee from scheduled/commercial bank of the value as specified in the 'Data Sheet' may be submitted in favor of "Tribal Research and Training Centre" payable at Pune.
- 2. The Bank Guarantee should be valid for 45 days beyond bid validity period (i.e. 45 days beyond 180 days (bid validity) from the last date of bid submission). The hard copy of the original instrument in respect of EMD must be submitted at the address as mentioned in Data Sheet (Part II of Section-II of RFP) on or before bid opening date and time as specified and a scan copy of the same must be uploaded along with the bid on https://mahatenders.gov.in/. Bid will not be accepted if original payment instrument against the submitted bid are not reached by the specified date and time.
- 3. The Micro and Small Enterprises (MSE) as defined in MSE Procurement Policy of Department of Micro, Small and Medium Enterprises or who are registered with the Central Purchase Organization, or with the Ministry of Electronics and Information Technology (MeitY), or Startups as recognized by Department of Industrial Policy & Promotion (DIPP) are exempted from submission of EMD. Such Bidders must furnish a valid certificate in this regard along with the bid.
- 4. Bids not accompanied with EMD shall be rejected as non-responsive.
- 5. The EMD of the unsuccessful bidders would be returned within 30 days of signing of the contract with the successful bidder.

# 2.1.7.1 Forfeiture of EMD

The entire EMD shall be forfeited by TRTI in the following events:

- 1. If the Bidder varies or modifies its proposal in manner not acceptable to the Purchaser after opening of Bid during the validity period or any extension thereof.
- 2. If the Bidder tries to influence the evaluation process.
- 3. If the Bidder/s selected as 'Service Provider chose to withdraw the Bid before the

Finalization process (failure to arrive at consensus by both the parties shall not be construed as withdrawal of Bid by the Bidder).

# 2.1.9 Performance Bank Guarantee (PBG)

- 1. 3 Sections III - Scope of Work

3.1 Part I – Description of Services

3.1.1 General

Maharashtra is the 3<sup>rd</sup> largest state in the country having 43,665 villages out of which 8,428 are tribal villages. According to the 2011 census, the tribal population in Maharashtra is 10.5 million which is 9.4% of the total population of the state. This makes Maharashtra the second largest state in terms of tribal population. This data indicates that a significant proportion of the population is tribal and their development is pivotal for overall development of the state. Almost 45 to 50 % of the Scheduled Tribe (ST) population lives in Scheduled Areas.

In 1973, the Dhebar Commission created Primitive Tribal Groups (PTGs) as a separate category, who are less developed among the tribal groups. In 2006, the Government of India renamed the PTGs as Particularly Vulnerable Tribal Groups (PVTGs). In Maharashtra, there are 3 Identified PVTGs by above cited commission, namely, Katkari, Kolam and Madia gond. PVTGs constitute the most vulnerable section among tribes and inhabit isolated, remote and difficult areas in small and scattered hamlets/ habitats. Most of these groups have not attained significant level of educational, economic progress and are having low health indices. Hence, priority is accorded for their protection and improvement in terms of the social indicators like livelihood, health, nutrition and education so as to decrease their vulnerability.

The challenges faced in the Scheduled Areas are mainly in the form of poor physical and network connectivity, electricity shortage, intermittent water supply, absence of transportation services, scarce infrastructure, lack of trained staff to carry out essential services, scarce livelihood opportunities are responsible for socio economic backwardness of the tribal communities.

The TRTIs aims at planning their socio-economic development in a comprehensive manner while retaining the culture and heritage of the community by adopting habitat development approach and intervening in all spheres of their social and economic life, so that a visible impact is made in improvement of the quality of life of PVTGs. As there is no clear picture of population and their vulnerability at most and current geographic

presence. TRTI as Tribal Research Institute wants to have preliminary survey of all the PVTG households and digitise it. To plan PVTG socio-economic development in a comprehensive manner while retaining the culture and heritage of the community by adopting habitat development approach and intervening in all spheres of their social and economic life, so that a visible impact is made in improvement of the quality of life of PVTG
- 2. This project will ensure the digitization of groups, which will help the Government to plan need, based policies for direct impact on the PVTGs in State of Maharashtra.

# .1.3 Scope of Work

- 1. The Mobile Application must be available on Tablets and mobile, and must be compatible with major operating systems of tablets and mobile. Currently it is envisioned to develop the app for following OS: a. Android
- 2. The Application Service Provider has to define the User Experience strategy under the following heads:
  - a. Define feature sets to be provided on mobile application based on client requirements especially keeping in mind the functionalities required for the Tribal Research and Training Institute, Pune, 411001.
  - b. Secondary survey/ data collection will cover PVTGs Socio-economic, statistical information, preliminary health status, educational status and geographic Presence, etc.

- c. Creation of policy related to terms of usage, privacy policy, content management policy etc., in consultation with TRTI and as per major App hosting platform (Android and web) standards.
- 3. Create a consistent and delightful user experience with consistent and unique themes and layouts which flows in from the overall brand values of TRTI and the spirit of the "TRTI' along with user goals. However, it does not provide any branding rights or marketing rights or advertising rights to the Application Service Provider, all the rights are reserved by TRTI.
  - 4. Define screen layouts and navigation to ensure delivery of structured content with easy and intuitive navigation.
    - 5. The downloaded and working apps should update and synchronize data from the server for technical updates and user information like contacts, photo, location, SMS and emails etc. only if accepted by user as per the policy related to terms of usage privacy, content management etc. The mobile app to be hosted by the application developer on all App stores.
    - 6. Agency has to collect Tribal Sub-Plan Backward Classes Welfare, Special Central Assistance, 275 (1) Particularly Vulnerable Tribal Development Plan, etc. list of beneficiaries, result reports, success stories of all the schemes implemented and coming year wise for the PVTG's under all the activities.
    - 7. Agency has to collect all kinds of numerical information of PVTG's Individual / Collective, Educational, Family, Religious, Cultural, Natural Social, Economic, Geographical, Population etc.
    - 8. GPS tracking of the Gramsathi's for live surveying for engagement
    - 9. To collect detailed information about the problems, causes, needs of the resource facilities available in the PVTG's areas, forest, village, pada, wada, geographical / natural condition, basic facilities available.
    - 10. To collect information about PVTG's Forest Rights Enforcement, Gram Sabha Participation / Decided Forest Rights, Community Rights etc.
    - 11. To collect detailed information of each PVTG's family and detailed information of each member of that family.
    - 12. To utilize the above factual information as referral material while conducting development plans, schemes, programs, campaigns and related development plans.
    - 13. To record the detailed information of the activities implemented accordingly in the presented agenda.
    - 14. To provide factual information about PVTG's education, health, income and all other necessary factors on the basis of this information and computerized data.

- 15. Agency has to surveying all the PVTGs and maintaining the data in digital form with dedicated portal for them.
- 16. To provide services as `System Integrator" to TRTI and Project Offices of TRTI.
- 17. To provide Hardware Solutions with Installation, Commissioning and Warranty (ICW) to meet out the requirement of TRTI and Project Offices of TRTI.
- 18. To provide Software Solutions to cater to the requirement of Various TRTI and Project Offices of TRTI.
- 19. To provide IT & ITES Solution on a turnkey basis suitable for end-to-end or partial functioning of TRTI and Project Offices of TRTI.
- 20. To provide Computer Education and Training to the officials of TRTI and Groundlevel officers.
- 21. GIS Mapping of Survey Data and preparation of Digital map. GIS Map preparation Ward wise and whole town area.

# 3.1.5Expected works from external source agency

- 1. Public tenders / EOIs or similar proposals will be received for the implementation of the scheme from the Tribal Research and Training Institute. According to the proposal, the system will be fixed by visiting the place and taking a demo to test the actual system capability.
- 2. All Profile Formats will be prepared by expert committee.
- 3. The algorithm will be developed through a decided to fixed system.
- 4. First of all, outline of this agenda / expected information report from it, information collection form, beneficiary / beneficiary list form, etc. this necessary samples will be fixed.
- 5. Accordingly, after all the samples have been prepared, the above proceedings will be finalized after detailed joint discussion through the Commissionerate, Additional Commissioner / Project Office representative and the said committee.

- 6. To take weekly / fortnightly / monthly demo as required from the development and fixed system regarding the development of algorithms and the progress of the above outline action. It will be the responsibility of the above committee to suggest or finalize the necessary amendments.
- 7. Obtaining information in the prescribed form regarding the schemes implemented and planned by all the project offices and the beneficiaries / beneficiary areas in relation to the PVTG's tribes at the time of development of the program. Achieve 100% information through continuous follow up.
- 8. Similarly to obtain information along with the list of beneficiaries and beneficiary areas in the prescribed form of the individual collective schemes planned for the PVTG's tribes under the tribal sub-plan and tribal component program.

- 3. The mobile application must be available 24\*7 after go live; mobile application must be free of cost to the general public and all the users.

# **Development**

Fact Finding and Requirement Gathering

The Functional Requirements as envisaged for the mobile app are described in this document. The Application Service Provider needs to Study these carefully and should consult with the concerned TRTI officials whenever necessary to obtain more details on the requirements of the project. It shall be the duty of Service Provider to refine functional requirements as needed during requirement gathering exercise. The Application Service Provider shall prepare detailed requirement gathering documents, for which the agency shall have a comprehensive discussion with TRTI officials and other stakeholders to ensure that each of the requirements mentioned in this RFP is covered. After approval of requirement gathering documents by concerned officials at TRTI, the Application Service Provider will start App Development.

# **Unique designs of Portal**

# **Design Structure**

- 1. The Application Service Provider needs to submit at least 1 homepage and internal pages design layouts for approval.
- 2. Approved design should have at least 2 or more color themes and one high contrast color theme.
- 3. Homepage should be attractive and well-constructed, so that it makes a good first impression to all app visitors.
- 4. Homepage should clearly communicate the purpose, and show all major options available on the app.
- 5. A consistent page layout must be maintained throughout the app.
- 6. All sectors framed by the respective Sector Skill Councils affiliated to NSDC/MSSDS should be visible on the first screen and should not go inside another activity.
- 7. All the relevant job roles (as selected and suggested by TRTI) as framed by the respective PVTG Tribes must be visible.
- 8. Graphic elements like buttons and icons should be simple and their meaning and symbolism should be self-explanatory and relevant
- 9. Wherever a graphic is used meaningful 'alt text' may be given.
- 10. There must be adequate color contrast between text and background.
- 11. Image should only be used when it adds value to the content.
- 12. Easy access to the homepage should be provided from every page.
- 13. The user must also be provided with an option to save favorite: sectors, job-roles and candidates.

# Compatibility & Scalability

- 1. The design of the app should adjust according to the screen size.
- 2. Design should be device independent and compatible to Tablets & Mobiles.
- 3. Design should not be font dependent. The content of the app should be readable with default standard fonts.

- 4. Design interface should be easy to configure, customize and extend Usage of HTML 5 and Responsive Grid system would be preferred
- 5. Optimized compressed CSS and JS should be used to allow minimum load time.
- 6. All styling should be handled through external style sheet. All the HTML tags should be styled through CSS, so that it should be uniformly consistent at each location where ever used.
- 7. The app in the Android platforms should be developed using native Android Java and Swift respectively.

# **Role Based User Access**

#### **Admin Role**

- 1. Administrator log-in with complete access
- 2. Only administrator can have the rights to permanently delete the content from the app that too only after taking proper back-up of the entity/system.
- 3. Only Admin should be able to add/delete the content of Applications.
- 4. Only Administration can read live stream data for monitoring purpose of Training centers, etc.
- 5. Continuous monitoring & tracking of the activities of the survey data, engagements and disengagements
- 6. Grievances submitted through the App must be accessible at first hand to Gramsathi's and Project Offices for furtherance to appropriate stakeholders

# Employer/Public User Role

- 1. Gramsathi's / Project Offices can view data on Application under various profile formats with villages, district & takula details etc.
- 2. GPS tracking of the Gramsathi's for live surveying for engagement.
- 3. Chat, call back request, call interface to communicate with the gramsathi's& PVTG Tribes.
- 4. Gaav/Pada/Villages of PVTG Area's should be searchable in map or manually (location wise) for surveying.
- 5. Complain/Grievance filing with audio/audio-visual/image or text file format uploading.
- 6. Gramsathi's rating and Feedback system for employer.

#### Gramsathi Role

- 1. Gramsathi login: candidates should be able to update their work location (area)
- 2. Chat and Call Back interface to communicate with TRTI employer.
- 3. The trained candidates should be able to update their work engagement status such as: Available/ Engaged/ Out of Station/ Switch Off mode.
- 4. The Gramsathi can view their track survey record
- 5. Complain/Grievance filing with audio/audio-visual/image or text file format uploading.
- 6. Recruiter/employer rating and feedback system for Gramsathi.

#### Localization

- 1. The mobile app should be Multilingual with scope to accommodate English & Marathi languages. The default language should be English, unless chosen otherwise by the user.
- 2. The application should be developed in an appropriate format to provide appropriate support for most of the languages to accommodate other languages apart from those mentioned above, if need arise.

# **Usage Statistics**

The usage generator must allow comprehensive usage statistics to be gathered, including user downloads, region wise statistics, most used pages and links, daily usage analytics reports including periodic comparative, analysis reports for number of gramsathi, number, Project Offices, TRTI Employers, Employability, Surveys, Job Roles, etc., leaving scope for flexible analysis for the purpose of planning

**Online Research Survey** 

- 1. To provide Individual Surveyor Login for conducting the survey with Geo tagging facility Survey or willconduct survey & collect data in real time basis through the already uploaded standard questionnaire in the mobile app. Facility to upload such multiple questionnaires for various survey may be provided from backend login in TRTI headquarter. Photo upload facility should be provided. Evaluation of Various Schemes-to provide facility to conduct evaluation of multiple schemes of various government departments.
- 2. Online Self data collection by targeted population to provide data entry facility to targeted population for evaluation/survey of existing schemes. It should be on the basis of Aadhaar. Mobile OTP Based facility. Also to provide the facility of upload of multiple questionnaires from the Backend login.
- 3. Statistical Report Generation on the basis of collection of data.
- 4. Compatible with research/statistical software.

**Public Grievance Redressal System** 

The App must have a dedicated feedback system for Public Grievances to be accessed by any stakeholder or end user for Submission of grievances against any stakeholder/authorized personnel pertaining to any matter. The option should be made available to all stakeholders for submission of grievances with option to upload Supporting documents in audio, visual, audiovisual and text document format. The grievance must show up at the CMS with notification to Public Grievance Officer and Administration for furtherance to concerned stakeholder. The scope for forwarding of grievance to relevant authority by the Public Grievance Officer may be integrated with the App on need basis

**Security Features** 

The mobile app should have the following security features:

1. Audit trail at administrator level should also be enabled. It should capture each activity done by each authorized user, IP address. Time stamp etc. to track that who, when and from where has done what changes in the application.

2. The app should be able to generate email and SMS Alerts and also historical report in the security report Viewable to the administrator containing the Time, IP address of attackers, the page under attack, and the parameter under attack with the attack values.

3. There should be a provision of blocking any IP or Network by assigning IP Address range from accessing the pages of admin module of the app; also the main app (so that identified attackers can be blocked)

4. The admin module, up loader module should be in separate folder so that HTTPS can be configured on the functionality that requires login action to be done. Administrator Panel should be secure enough. Other than username password there should be other secure means for login into admin panel. Onetime password and digital certificate based login facility may be provided on a need basis.

# Non-Functional Requirement.

1. **Scalability:** The architecture is capable to take care of high volume traffic

2. Portability: The application components should be portable with minimal effort.

3. Expandability: It's easy to extend the services provided with minimal changes to other components that is allowing easier development of new applications based on the existing Components and layers.

4. Availability: The services at each layer allow for high availability.

5. Reliability: The data being transferred and the processing of the same are reliable. That is, persistence must be provided at each layer and each interface between layers

6. Recoverability: The manner in which the system recovers from failure.

7. Backup and Restoration: Provide the back-up and restore functionality for the application

8. Interoperability: Interoperability features permit the underlying disparate sub systems or external systems to work together seamlessly, while hiding much of the complexity required joining these pieces together.

9. Administrative & Management Capability: The services provided at each layer shall be easy to manage (with a clear interface for administration). Also, the component must be able

to interface with the standard monitoring tools available.

- 10. Security capability: Provides services to protect access to sensitive resources or information.
- 11. Font resizer: Options given for different sizes of font for old age/ low vision users and customized to various mobile application themes.

# Hosting Servers & Market Place Launch (Go-Live)

The application hosted at suitable cloud/servers to be able to meet the SLA of interaction of users with the app downloaded from App store/Google play store.

2. Source Code and Database of the mobile application will be deployed by Application Service

Provider on Cloud.

3. Digital Certificate / Document Signer/ Security Audit for staging server will be taken by Application Service Provider.

4. Installation of Digital Certificate will be carried out by the Application Service Provider.

5. Installation of all software related to installation will be the responsibility of Application Service Provider.

6. Application Service Provider will be responsible for transferring the source code/ database to production server.

7. The requirement of necessary licenses required for the hosting of the mobile application on major app stores will be provided by the Application Service Provider. However it is clarified that these license are to be procured by the selected Application Service Provider.

# Training & Handholding support

1. Proper training has to be provided to Nominated TRTI staff and Project Offices Staff.

Training will be conducted at location decided by TRTI and 18 Project Offices.

All the Training material, user; manuals in soft copy in printable format will be provided by the Application Service Provider to TRTI (i.e. Marathi and English).

4. Onsite support to team of officers as per requirement.

Maintenance phase

The Application development agency should provide maintenance support for application post development and delivery up to one year from the Go Live.

### Scope of maintenance support

- 1. Technical Assistance: Application Service Provider will be responsible for providing technical assistance on any issue during working days/hours.
- 2. Fixing Security Vulnerabilities whenever any issue is reported or in the case of cyber-attacks.

3. Onsite Training & Handholding of user representatives.

- 4. Addressing App Performance related issues to fix issues like no response, slow response, app crashing etc.
- 5. Rectification of bugs like content formatting issues, image placement, link mismatch etc. immediately after user request.
- 6. Change Requests like changing static images, text, updating your privacy policy, app terms of use, disclaimers etc.
- 7. Any change requests suggested by TRTI Authority will be implemented without any additional cost.
- 8. Delivering and managing patch management, quick response system for wellbeing and healthy operation of the web based system during the warranty and through the subsequent maintenance contracts (if any).

#### **Deliverables**

1. Mobile app based on requirement of TRTI along with database.

2. Soft copy of user manual for each module of mobile app

- 3. Onsite Training on administration, operation & maintenance of developed app at TRTI office or as per suggested location by TRTI. Training Manual/ presentations would also form part of deliverables.
- 4. The database backup and restoration process properly documented.
- 5. Test Report w.r.t. the following:
  - i. Functionality
  - ii. Security
  - iii. Other
- 6. It is expected from the service provider that they appoint one full time Project Manager and support team for coordination and interaction with TRTI.

#### Category of SLA

This Service Level Agreement document provides for minimum level of services required as per contractual obligations based on performance Application Service Provider shall ensure provisioning of all required services while monitoring the performance of the same to effectively comply with the performance levels. The services provided by the Application Service Provider shall be reviewed by indicators and measurements thereof. The TRTI that shall:

a) Regularly check performance of the Application Service Provider against this SLA

b) Review of statistics related to rectification of outstanding faults and agreed changes

The SLA is to be observed as in phased manner.

The SLA has been logically segregated in the following categories:

i. Deployment SLA - SLA is applicable as per the scope for development, deployment.

ii. Operational SLA - SLA applicable after the acceptance of the App and the entire support period of the project.

#### 3.1.6 Others

Controlling Officer - Commissioner, Tribal Research and Training Institute, Pune Coordinating officer - Project Officers, Integrated Tribal Development Project, Dahanu, Jawahar, Shahapur, Pen, Ghodegaon, Nashik, Kinwat, Pandharkavada, Pusad, Dharani, Nagpur, Deori, Bhandara, Chandrapur, Chimur, Gadchiroli, Bhamragad, Aheri.

(On behalf of the Commissioner, Tribal Research and Training Institute, Pune, 18 Project Officers, will coordinate the projects at ground level. The Hon'ble Commissioner will be informed about it from time to time.)

# 3.2 Part II – Service Level Agreement

- 1. The purpose of this Service Level Agreement (SLA) is to clearly define the levels of service which shall be provided by the Service Provider to the Purchaser for the duration of this Contract.
- 2. The benefits of this SLA are to:
  - a. Trigger a process that draws the Purchaser and Service Provider management's attention to certain aspect of performance when that aspect drops below an agreed upon threshold or target.
  - b. Makes explicit the expectations that Purchaser has for performance from the selected Service Provider.
  - c. Helps Purchaser control the levels and performance of Service Provider's services.
- 3. The Purchaser may initiate an interim review to check the performance and the obligations of the Service Provider and, in case desired, review and revise the SLA. The Purchaser reserves the right to revisit the SLAs at a later date based on the learning from past experience and stabilization of operations. The Purchaser also reserves the right to waive or relax part or whole of SLA applicable for the duration or to the specific Service Provider.
- 4. The Purchaser or its designated officials shall have the right to conduct quality and process audit of the Service Provider, at any point of time, in respect of SLA or any other parameters at any time without prior notice.
- 5. The Service Provider shall submit reports on the SLA and key parameter defined in this Section to the Purchaser in accordance with the specified formats and reporting periods. The Purchaser may ask the Service Provider to provide clarifications on these reports as well as the measurement tools and processes utilized by the Service Provider for reporting. The Purchaser should have full access to check the status/report at any time. The Service Provider shall extend full cooperation for conducting such audits.

# 3.2.1Service Level Agreement (SLA) Parameters

The Selected Service Provider shall agree to the following service level agreement (SLA) parameters while providing Implementation of Development of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes. The SLA parameters are divided into 2 (two) types:

## 3.2.1.1One-Time SLA Parameters

- 1. Deliverable: Commencement of services
- 2. Definition: Commence the service as per the scope of work of RFP
- 3. Measurement Criteria: Within 1 year from the date of signing the contract between the Purchaser and the Service Provider
- 4. Timeline
- a. Within 1 year from the date of signing the contract between the Purchaser and the Service Provider:  $\mathbf{Penalty} \mathbf{NIL}$
- b. Delay of every 1 week after the one year from the date of signing the contract between the Purchaser and the Service Provider: **Penalty** INR 500/- per week of delay. Capped at maximum of INR 10,000/-.
- c. Delay beyond 20 weeks after the one year from the date of signing the contract between the Purchaser and the Service Provider: Penalty TRTI may choose to terminate the contract and PBG can be forfeited.

#### 3.2.1.2Critical Error

- 1 .Poor Implementation of developing of Web and Mobile application (Android).
- 2. Data Collapse.
- 3. Any other error directly attributed to Implementation of Development of Web and Mobile Application (Android), as per the specification or implicit requirements.
- 4. Wrong Delivery

Note: TRTI reserves the right to personally audit Implementation of Development of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes by the selected service provider before dispatch/work done or at any time during the period of contract with TRTI.

**Penalties for Critical Errors:** Such errors shall, in the normal course, never occur. However, on occurrence of such an error, the Service Provider will be required to:

- 1. Application Data Collapse –The lost data of survey will be cost of which shall be borne by the Service Provider.
- 2. Delivery cost of application survey shall be borne by the Service Provider.
- 3. The Service Provider shall also analyze the root cause of error(s) occurred and implement Corrective Measures within 2 days of report. Objective evidence of corrective measures needs to be provided to the Purchaser.
- 4. The penalties for variation from benchmark and for critical errors are mutually exclusive and shall apply independent of each other.

Above SLA is also mutually exclusive to other SLAs and will be applied separately.

**Important:** Total penalty applicable shall be capped at 10% of the contract value. In case, the penalty levied on any service provider exceeds 10% of the invoice value, TRTI shall have the discretion of terminating the contract and getting the work done by any other agency.

# 4 Section IV – General and Special Conditions of Contract

## 4.1Part I - General Conditions

# 4.1.1General Conditions

#### 4.1.1.1Definitions

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- "Applicable Law" means any statute, law, ordinance, notification, rule, regulation, judgment, order, decree, bye-law, approval, directive, guideline, policy, requirement or other governmental restriction or any similar form of decision applicable to the relevant party and as may be in effect on the date of the execution of this Agreement and during the subsistence thereof, applicable to the Project.
- 2. "Purchaser" means the entity purchasing the services under this Contract.
- 3. "Contract" means the Agreement entered into between the Purchaser and the Service Provider, together with the contract documents referred to there in, including all the attachments, appendices, annexure, schedules and all documents incorporated by reference therein.
- 4. "GC" means these General Conditions of Contract (Part-I of Section IV).
- 5. "Contract Price" means the price to be paid for the performance of the Services, in accordance with Clause 4.1.6 of GC, subject to such additions and adjustments thereto or deductions therefrom, as may be made pursuant to the Contract.
- 6. "Effective Date" means the date on which this Contract comes into force and effect pursuant to Clause 4.1.2.1 of GC.
- 7. "Government" means the Government of Maharashtra.
- 8. "Service Provider" means any private or public entity that will provide the Services to the Purchaser under the Contract. The Service Providers are the entity, whose bid to perform the Contract has been accepted by the Purchaser and is named as such in the Agreement.
- 9. "Party" means the Purchaser or the Service Provider, as the case may be, and "Parties" means both of them.
- 10. "Personnel" means persons hired by the Bidder and assigned to the performance of the Services or any part thereof.
- 11. "SC" means the Special Conditions of Contract (Part-II of Section IV) by which the GCmay be amended or supplemented.
- 12. "Services" means the work to be performed by the Service Provider pursuant to this Contract, as described in Scope of Work at Section-III of RFP hereto.
- 13. "Bidder" means the entity bidding for the services under the Contract.
- 14. "Resident" means resident of India.
- 15. "TRTI" means Tribal Research and Training Centre.
- 16."In writing" means communication in written form with proof of receipt.

## 4.1.1.2Relationship between parties

Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between the Purchaser and the Service Provider. The Service Provider, subject to this Contract, has complete charge of Personnel performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

### 4.1.1.3Law Governing Contract

"This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the applicable Laws of India. The bidder and the vendor in the provision of its services under the contract shall be governed at all times by the provisions of Government of India and the regulations framed there under as amended from time to time. Notwithstanding anything contained therein, if the bidder/vendor contravenes any provisions of Government of India and the regulations framed there under, as applicable to the services rendered under this RFP/Contract, the bidder/vendor shall be liable to applicable penal provisions prescribed therein, in addition to, the penalties/provisions provided in this RFP/contract."

#### 4.1.1.4Language

This Contract has been executed in English, which shall be the binding and controlling language for all matters relating to the meaning or interpretation of this Contract.

#### 4.1.1.5 Notices

- 1. Any notice, request or consent required or permitted to be given or made pursuant to this Contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the address specified in the SC.
- 2. A Party may change its address for notice hereunder by giving the other Party notice in writing of such change to the address specified in the SC.

#### 4.1.1.6Location

The Services of Implementation of Development of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes shall be performed at such locations, as the Purchaser may approve.

## 4.1.1.7Authorized Representatives

Any action required or permitted to be taken, and any document required or permitted to be executed under this Contract by the Purchaser or the Bidder may be taken or executed by the officials specified in the SC.

#### 4.1.1.8Taxes & Duties

1. The Service Provider and their Personnel shall pay all such direct and indirect taxes, duties, fees and other impositions levied under the Applicable Laws of India.

2. The Bidder may be subject to taxes, such as, but not limited to GST, Service tax, duties,

fees, levies etc. on amounts payable by the Purchaser under the Contract. The quoted cost in the financial bid shall be exclusive of all such taxes. Such taxes shall be quoted separately.

3. If there is any reduction or increase in duties and taxes due to any reason whatsoever, after Notification of Award, the same shall be passed on to the Purchaser/Service Provider as the case may be.

### 4.1.1.9Fraud & Corruption

#### 4.1.1.10 Definitions

It is the Purchaser's policy to require that the Purchaser as well as Service Provider observe the highest standard of ethics during the selection and execution of such contracts. The Purchaser also requires that the Service Provider does not demand any service charges from the Resident unless the same is agreed with the Purchaser in advance. In pursuance of this policy, the Purchaser defines, for the purpose of this provision, the terms set forth below as follows:

- 1. "Corrupt Practice "means the offering, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the selection process or in contract execution;
- 2. "fraudulent practice" means a misrepresentation or omission of facts in order to
- a. influence a procurement process or the execution of a contract to the Purchaser;
- 3. "Collusive practices" mean a scheme or arrangement between two or more bidders, with or without the knowledge of the Purchaser, designed to establish prices at artificial, non-competitive levels;
- 4. "coercive practices" mean harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process, or affect the execution of a contract;
- 5. "Unfair trade practices" mean supply of services different from what is ordered on, or
  - a. Change in the Scope of Work which was agreed.

## 4.1.1.11 Measures to be taken by the Purchaser

- 1. The Purchaser may terminate the contract if it determines at anytime that representatives of the Service Provider were engaged in corrupt, fraudulent, collusive or coercive practices during the selection process or the execution of that contract, without the Service Provider having taken timely and appropriate action satisfactory to the Purchaser to remedy the situation;
- 2. The Purchaser may also apply sanction against the Service Provider, including declaring the Service Provider ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the Service Provider has,

directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for, or in executing, a Purchaser-financed contract.

## 4.1.1.12 Commissions & Fees

Purchaser will require the successful Service Provider to disclose any commissions or fees that may have been paid or are to be paid to agents, representatives, or commission agents with respect to the selection process or execution of the contract. The information disclosed must include at least the name and address of the agent, representative, or commission agent, the amount and currency, and the purpose of the commission or fee.

### 4.1.1.13 Interpretation

In this Contract unless a contrary intention is evident:

- the clause headings are for convenient reference only and do not form part of this Contract;
- 2. unless otherwise specified, a reference to a clause number is a reference to all of its subclauses;
- 3. unless otherwise specified, a reference to a clause, sub-clause or section is a reference to a clause, sub-clause or section of this Contract including any amendments or modifications to the same from time to time;
- 4. a word in the singular includes the plural and a word in the plural includes the singular;
- 5. a word importing a gender includes any other gender;
- 6. a reference to a person includes a partnership and a body corporate;
- 7. a reference to legislation includes legislation repealing, replacing or amending that legislation;
- 8. where a word or phrase is given a particular meaning it includes the appropriate
- a. grammatical forms of that word or phrase which have corresponding meanings;
- 9. In the event of an inconsistency between the terms of this Contract and the Bid document and the Proposal, the terms of this Contract hereof shall prevail.

# **4.1.2** Commencement, Completion, Modification & Termination of Contract

## 4.1.2.1 Effectiveness of Contract

This Contract shall come into effect on the date the Contract is signed by both parties and such other later date as may be stated in the SC. The date, the Contract comes into effect is defined as the Effective Date.

## 4.1.2.2Termination of Contract

# 4.1.2.2.1 Termination of Contract for Failure to Become Effective

If this Contract does not become effective within such time period as defined in the SC, Purchaser through a written notice to the other Party, declare the offer to sign the contract to be null and void. Purchaser may ask next ranked bidder to sign the contract or may publish new RFP.

# 4.1.2.2.2 Termination of Contract subject to necessary approvals

Notwithstanding the duration of the contract stated in GC 4.1.2.4, TRTI, reserves the right to terminate the contract at any time without prejudice or liability.

# 4.1.2.3Commencement of Services

The service providers shall begin carrying out the Services within 2 day (from the date of signing the contract between the Purchaser and the service provider).

# 4.1.2.4Expiration of Contract

Unless terminated earlier pursuant to Clause GC4.1.2.2 hereof, this Contract shall expire at the end of such time period, after the Effective Date or after the agreed volume/quantity has been delivered, as specified in the SC. The Contract may be extended by a period of one year plus one year (up to Two years on 'year on year' basis or a part thereof) subject to satisfactory performance by the Bidder.

## 4.1.2.5Entire Agreement

This Contract contains all covenants, stipulations and provisions agreed by the Parties.

### 4.1.2.6 Modifications or Variations

a. Any modification or variation of the terms and conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties. However, each Party shall give due consideration to any proposals for modification or variation made by the other Party.

### 4.1.2.7Force Majeure

#### 4.1.2.7.1 Definition

- 1. For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable and not brought about by or at the instance of the Party claiming to be affected by such events and which has caused the non- performance or delay in performance, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other extreme adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by Government agencies.
- 2. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected both to take into account at the time of the conclusion of this Contract, and avoid or overcome in the carrying out of its obligations hereunder.

3. Force Majeure shall not include insufficiency of funds or inability to make any payment required hereunder.

#### 4.1.2.7.2 No Breach of Contract

The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under, this Contract in so far as such inability arises from an event of Force Majeure, provided that the Party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.

#### 4.1.2.7.3 Measures to be taken

- a. A Party affected by an event of Force Majeure shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.
- b. A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any case not later than fourteen (14) days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.
- c. Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.
- d. During the period of their inability to perform the Services as a result of an event of Force Majeure, the Service Provider, upon instructions by the Purchaser, shall either:
- i. immobilize, or
- ii. Continue with the Services to the extent possible, in which case the Service Provider shall continue to be paid proportionately and on pro- rata basis, under the terms of this Contract.
- d. In the case of disagreement between the Parties as to the existence or extent of Force Majeure, the matter shall be settled according to Clause GC 4.1.8.

#### 4.1.2.8 Suspension

The Purchaser may, by written notice of suspension to the Service Provider, suspend all payments to the Service Provider hereunder if the Service Provider fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and(ii) shall allow the Service Provider to remedy such failure, if capable of being remedied, within a period not exceeding thirty (30) days after receipt by the Service Provider of such notice of suspension.

#### 4.1.2.9Termination

#### 4.1.2.9.1 Termination

- a. The Purchaser may, without prejudice to any other remedy for breach of Contract, by 30 days prior written notice of default sent to the service provider, terminate the Contract in whole or in part in case of the occurrence of any of the events specified in paragraphs (a) to (k) of this Clause GC 4.1.2.9.
- i. If the service providers fail to deliver Services within the time period(s) specified in the Contract, or any extension thereof granted by the Purchaser; OR
- ii.If the service providers fail to perform any other obligation(s) under the contract."
- b. If the Service Provider becomes in solvent or goes into liquidation or bankruptcy or receivership whether compulsory or voluntary.
- c.If the Service Provider, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
- d.If, as the result of Force Majeure, the Service Providers are unable to perform a material portion of the Services for a period of not less than sixty (60) days.
- e.If the Service Provider submits to the Purchaser a false statement which has a material effect on the rights, obligations or interests of the Purchaser.
- f.If the Service Provider places itself in position of conflict of interest or fails to disclose promptly any conflict of interest to the Purchaser.
- g.If the Service Provider fails to provide the quality services as envisaged under this Contract. The Purchaser may make judgment regarding the poor quality of services, the reasons for which shall be recorded in writing. The TRTI may decide to give one chance to the Service Provider to improve the quality of the services.
- h.If the Service Provider has been blacklisted by the TRTI and/or any other government agency or disqualified for any reason.
- i. If the Service Provider fails to fulfill its obligations under Clause G.C 4.1.3 hereof.
- j. If the Service Provider fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause GC 4.1.8 hereof.
- k. In the event of Service Provider found:
- i.Provided incorrect information to TRTI.
- ii. Non co-operative during audits conducted by TRTI/ TRTI Regional Office or auditing agencies appointed for the purpose.
- l. "Iftheserviceproviderdisclosesanyconfidentialinformationduringits engagement with TRTI, TRTI may terminate this Contract, forthwith." Confidentiality Obligations shall survive the termination of this Contract.
- m. In the event the Purchaser, in its sole discretion and for any reason whatsoever, decides to terminate the Contract in whole or in part, pursuant to Clause4.1.2.9.1 of GC, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, services similar to those undelivered or not performed, and the Service Provider shall be liable to the Purchaser for any additional costs for such similar services. However, the Service Provider shall continue performance of the Contract to the extent not terminated.

## 4.1.2.9.2 Cessation of Rights and Obligations

Upon termination of this Contract pursuant to Clauses GC 4.1.2.2 or GC 4.1.2.9 hereof, or upon expiration of this Contract pursuant to Clause GC 4.1.2.4 hereof, all rights and obligations of the Parties hereunder shall cease, except:

a.such rights and obligations as may have accrued on the date of termination or expiration; b.the obligation of confidentiality set forth in Clause GC 4.1.3.4 hereof;

c.the Service Provider's obligation to permit inspection, copying and auditing of their accounts and records set forth in Clause GC 4.1.3.6 hereof; and

d.any right which a Party may have under the Law.

#### 4.1.2.9.3 Cessation of Services

Upon termination of this Contract by notice of either Party to the other pursuant to Clauses GC 4.1.2.9.1 or GC 4.1.2.9.2 hereof, the Service Provider shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents, data, and/ or any other material prepared by the Service Provider and equipment and materials furnished by the Purchaser, the Service Provider shall proceed as provided, respectively, by Clauses GC 4.1.3.9 or GC 4.1.3.10hereof.

#### 4.1.2.9.4 Payment upon Termination

Upon termination of this Contract pursuant to Clauses GC 4.1.2.9.1, the Service Provider shall be entitled such undisputed payments as per the following:

a.If the Contract is terminated pursuant to Clause GC 4.1.2.9.1 (d), (g), k(i) to k(iii) then the service provider shall be eligible for remuneration pursuant to Clause GC 4.1.6.3 hereof for Services satisfactorily performed prior to the effective date of termination;

b.If the agreement is terminated pursuant of Clause GC 4.12.9.1 other than those mentioned in (a) above, the Service Provider shall not be entitled to receive any agreed payments upon termination of the contract. However, the Purchaser may consider making such undisputed payment for the part satisfactorily performed, if such part is of economic utility to the Purchaser. Applicable under such circumstances, upon termination, the Purchaser may also impose liquidated damages as per the provisions of Clause GC 4.1.9 of this agreement. The Service Provider will be required to pay any such liquidated damages to Purchaser within 30 days of termination date.

#### 4.1.2.9.5 Disputes about Events of Termination

If either Party disputes whether an event specified in Clause GC 4.1.2.9.1 hereof has occurred, such Party may, within thirty (30) days after receipt of notice of termination from the other Party, refer the matter to Clause GC 4.1.8 hereof, and this Contract shall not be terminated on account of such event except in accordance with the terms of any resulting arbitral award.

#### 4.1.2.10 Extension of Contract

The contract may be extended by a period of one year plus one year (up to Two years on 'year on year' basis or part thereof), subject to satisfactory performance by the Bidder and acceptance of both the parties.

#### 4.1.2.11 Options Clause

The purchaser can exercise an option to procure an additional quantity not exceeding 40% of the original contracted quantity on the same terms and conditions. This option will be applicable within the currency of the contract. It will be entirely at the discretion of the purchaser to exercise this option.

### 4.1.30bligations of the service provider

#### 4.1.3.1Standard of Performance

The Service Provider shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology with safe and effective equipment, men, machinery, materials and methods. The Service Provider shall always act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to the Purchaser, and shall at all times support and safeguard the Purchaser's legitimate interests in any dealings with third Parties.

## 4.1.3.2 Service Provider Not to Benefit from Commissions, Discounts, etc.

The payment of the Service Provider pursuant to Clause **GC 4.1.6** shall constitute the Service Provider's only payment in connection with this Contract or the Services, and the Service Provider shall not accept for their own benefit any trade commission, discount, or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of their obligations under the Contract, and the Service Provider shall use their best efforts to ensure that the Personnel and agents of either of them similarly shall not receive any such additional payment.

#### 4.1.3.3 Prohibition of Conflicting Activities

The Service Provider and their Personnel shall not engage, either directly or indirectly, in any business or professional activities which would conflict with the activities assigned to them under this Contract.

a.The Service Provider shall protect from unauthorized access, loss or damage and also keep safe, secure and confidential all demographic information, all documents, data and information of any nature provided to the Service Provider for the discharge of services.

b.The Service Provider shall not store, copy, publish, print, interfere, tamper with or manipulate the information/data received from TRTI, other than required for discharge of services.

c.The Service Provider shall not give access to the information or data collected and received from TRTI in the course of discharge of services, to any person who is not authorized to handle the information or data. Information should only be given to an authorized personnel and only used in the manner prescribed by TRTI.

d.The service provider (PSPs) shall also provision for periodic (half yearly) third party audits from Cert-In(computer emergency response team—India) empaneled auditors at no extra cost to TRTI.

## 4.1.3.4General Confidentiality

"Except with the prior written consent of the Purchaser, the Bidder and its personnel shall not at any time communicate to any person or entity, any confidential information acquired in the course of discharge of Services, nor shall the Bidder and the personnel make public the recommendations formulated in the course of or as a result or discharging the Services.

Bidder should comply with the IT Act, 2000 and other related Laws/ Acts/ Policies/ Guidelines/ Regulations, etc. Including the amendments thereof particularly with respect to data confidentiality and privacy. The Bidder shall furnish a Non- Disclosure Agreements, as per format provided in Appendix 'D' of Section V as part of its proposal."

# 4.1.3.5 Insurance to be Taken Out by the Service Provider

The Service Provider shall take and maintain insurance against risks and coverage as per the industry standards and as per the applicable laws at their own cost, and such insurances as shall be specified in the **SC**; and (b) at the Purchaser's request, shall provide evidence to the Purchaser showing that such insurance has been taken and maintained and the current premiums have been paid.

# 4.1.3.6 Accounting, Inspection and Auditing

a. The Service Provider

- i.shall keep accurate and systematic accounts and records in respect of the Services hereunder, in accordance with internationally accepted accounting principles and in such form and detail as will clearly identify all relevant time changes and costs, and the bases thereof, and
- ii. Shall periodically permit the Purchaser or its designated representative and/or the Purchaser, and up to five years from expiration or termination of this Contract, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by the Purchaser or the Purchaser, if so required by the Purchaser. The Audit expenses shall be borne by the Service Provider.
- b.The Purchaser shall have the right to carry out inspection checks, audits of the Service Provider's premises and/ or locations, facilities, or point of delivery of services performed under this contract.
- c. The Purchaser shall have the right to carry out scheduled/ un-scheduled visits to any of the locations, premises & facilities and oversee the processes and operations of the Service Provider.
- d. If a third-party audit is conducted at the instance of PSP, the cost of audit will be borne by the PSP

## 4.1.3.7 Sub-contracting

The Service Provider shall not be permitted to sub-contract any part of its obligations, duties, or responsibilities under this contract without TRTI's prior written approval.

# 4.1.3.8 Reporting Obligations

The Service Provider shall submit to the Purchaser the reports and documents with regard to Implementation of Development of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes.

### 4.1.3.9 Rights of Use

All rights of use of any process, product, service, or data developed, generated, or collected, received from TRTI or any other task performed by the Service Provider under the execution of the contract, would lie exclusively with the Purchaser or its nominated agencies in perpetuity free from all liens, encumbrances, and other third party rights and the Service Provider shall, wherever required, take all steps that may be necessary to ensure the transfer of such rights in favour of the Purchaser or its nominated agencies.

# 4.1.3.10Safety & Security of Data, Premises, Location/site

- a.The Data provided by the Purchaser to the Service Provider, for Implementation of Development of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes, is the property of the Purchaser. The Service Provider shall displaydue diligence in the handling of the said data and be responsible for the Data, thus provided.
- b.The Service Provider shall not use the information, the name or the logo of the purchaser and or Government of India except for the purposes of providing the services as specified under this contract.
- c.The Service Provider shall not use and/or transmit any information, data, layouts, designs, diagrams, storage media (hard disk/tapes) or any other goods/material in physical or electronic form, which are proprietary to or owned by the Purchaser, without prior written permission from the Purchaser.
- d.The Service Provider shall follow the Security Guidelines issued by Government of India.
- e.Certificate of 'Data deletion' to be provided by the Service Provider, at the time of raising the invoice.
- f.The Service Provider would be governed by the provisions of the Law of the Land, including but not limited to the IT Act, other relevant Acts.
- g.The Purchaser reserves the right to carry out third party Audits of the Service Provider to ensure compliance of stated and implicit requirements
- h.The rogue behavior of the employees of Service Provider shall fall under the 'Unlimited liability' to the Service Provider.

# 4.1.3.11 Equipment & Materials Provided by the Service Provider

Equipment or materials brought into India by the Service Provider and the Personnel and used either for the Project or personal use shall remain the property of the Service Provider or the Personnel concerned, as applicable.

# 4.1.3.12Intellectual Property Rights (IPR)

The intellectual property rights to all the outputs, deliverables, data, and reports developed during the execution of this Contract shall remain sole property of the Purchaser.

### 4.1.3.13Assignment

The Service Provider shall not assign, in whole or in part, any of their obligations under this Contract.

## 4.1.4 Service provider's personnel

#### 4.1.4.1General

The Service Provider shall employ and provide such qualified and experienced Personnel as are required to carry out the Services.

### 4.1.4.2Project Manager

If required by the Purchaser, the Service Provider shall ensure that at all times during the Service Provider's performance of the Services a Project Manager, acceptable to the Purchaser, shall take charge of the performance of such Services.

### 4.1.5 Obligations of the purchaser

## 4.1.5.1Assistance and exemptions

Unless otherwise specified in the **SC**, the Purchaser shall use its best efforts to ensure that the Government shall:

- a. Issue to officials, agents and representatives of the Governmental such instructions as may be necessary or appropriate in its opinion for the prompt and effective implementation of the Services.
- b. Provide to the Service Provider and Personnel any such other assistance as may be required in its opinion specified in the SC.

# 4.1.5.2Change in the applicable Law Related to Taxes and Duties

- a. The Service Provider and their Personnel shall pay taxes, duties, fees, and other impositions levied under the Applicable Laws of India.
- b.The Service Provider shall be entirely responsible for all taxes, duties, octroi, license fees, and demurrage charges etc., incurred of the contracted Services to the Purchaser. If there is any reduction or increase in duties and taxes due to any reason whatsoever, after Notification of Award, the same shall be passed on to the Purchaser/Service Provider.

## 4.1.5.3Payment

Inconsideration of the Services performed by Service Provider under this Contract, the Purchaser shall make to the Service Provider such payments and in such manner as is provided by Clause **GC 4.1.6** of this Contract.

# 4.1.6 Payments to the service provider

# 4.1.6.1Payment for Services

- a.The Proof of delivery of Web and Mobile Application (Android) for Digitization & Computerization of information Of PVTG Tribes shall be reported to the Purchaser by the selected bidder.
- b.The Purchaser shall take into account the Proof of Delivery (PoD) as base.
- c.The amount payable shall be finalized after taking into account the Penalties and Exemptions, if any applicable.
- d.The Purchaser shall make the payment within 30 days of receiving the invoice from the Service Provider.

# 4.1.6.2Currency of Payment

All payments shall be made in Indian Rupees (INR).

## 4.1.6.3Terms of Payment

The payments in respect of the Services shall be made as follows:

- a.The Service Provider shall submit the final invoice for payment when the payment is due as per agreed terms on successful delivery and acceptance of services. The payment shall be released as per the work-related milestones achieved.

## 4.1.8Settlement of disputes

#### 4.1.9Liquidated damages

## 4.1.11 Limitation of liability

- 1. The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. The Bidder(s)/Contractor(s) commits themselves to observe the following principles during his participation in the tender process and during the contract execution. a)The Bidder(s)/contractor(s) will not, directly or through any other persons or firm, offer promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage or during the execution of the contract.
- b)The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non- submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- c)TheBidder(s)/Contractor(s)willnotcommitanyoffenceundertherelevant IPC/PC Act; further the Bidder(s)/Contractors will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or documents provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- d)The Bidder(s)/Contractor(s) of foreign origin shall disclose the name and address oftheAgents/representativesinIndia,ifany.Similarly,thebidder(s)/contractor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any. All the payments made to the India agent/representative have to be in Indian Rupees only.
- e)The Bidder(s)/Contractor(s) will, when presenting their bid, disclose any and all payments made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- f) Bidder(s)/Contractor(s) who have signed the Integrity pact shall not approach the courts while representing the matter to IEMs and shall wait for their decision in the matter.
- 2. The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.

## Section3:Disqualification from tender process and exclusion from future contract

If the Bidder(s)/Contractor(s), before award or during execution has committed a transgression through a violation of Section 2 above or in any other form such as to put his reliability or credibility in question, the Principal is entitled to disqualify the Bidder(s)/Contractor(s) from the tender processor to terminate the contract, if already signed, for such reasons.

## **Section 4: Compensation for Damages**

- 1. If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to Earnest Money Deposit/Bid Security.
- 2.If the Principal has terminated the contract according to Section3, or if the Principal is entitled to terminate the contract according to Section3, The Principal shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

# **Section 5: Previous Transgression**

- 1. The Bidder declares that no previous transgressions occurred in the last three years with any other company in any country conforming to the anti-corruption approach or with any other government (Central/State/PSU's) in India that could justify his exclusion from the tender process.
- 2.If the bidder makes incorrect statement on this subject, he can be disqualified from the tender process and appropriate action can be taken including termination of the contract, if already awarded, for such reasons.

# Section 6: Equal treatment of all Bidders/Contractors/Subcontractors.

- 1. In case of sub-contracting, the principal contractor shall take the responsibility of the adoption of Integrity pact by the sub-contractors.
- 2. The Principal will enter into agreements with the identical conditions as this one with all bidders, contractors and sub-contractors.
- 3. The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

# Section7: Criminal charges against violating Bidder(s)/Contractor(s)/Subcontractors(s).

If the Principal obtains knowledge of conduct of a Bidder(s)/ Contractor(s) or sub-contractor, or of an employee or a representative or an associate of a bidder, contractor or sub-contractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

# Section 8: Independent External Monitor/Monitors

- 1. The Principal appoints competent and credible Independent External Monitor for this Pact after approval by Central Vigilance Commission. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- 2. The Monitor is not subject to instructions by the representatives of the parties and performs his/her functions neutrally and independently. The Monitor would have access to all contract documents, whenever required. It will be obligatory for him/her to treat the information and documents of bidders /contractors as confidential. He reports to the CEO, TRTI.
- 3. The Bidder(s)/Contractor(s) accepts that the Monitor has the right to access with out restriction to all project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his/her request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors.
- 4. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s) / Contractor(s) / Subcontractor(s) with confidentiality. The Monitor has also signed declarations on 'Non-disclosure of Confidential Information' and of 'Absence of Conflict of Interest'. In case of any conflict of interest arising at a later date, the IEM shall inform CEO, TRTI and recuse himself/herself from that case.
- 5. The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option

to participate in such meetings.

6. As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit nonbinding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

7. The Monitor will submit a written report to the CEO, TRTI within 8 to 10 weeks from the date of reference or intimation to him by the Principal and, should be occasion arise, submit

proposals for correcting problematic situations.

8. If the Monitor has reported to the CEO, TRTI, a substantiated suspicion of an offence under relevant IPC/PC Act, and the CEO, TRTI has not, within the reasonable time taken visible action to proceed against such offence or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.

9. The word "Monitor" word include both singular and plural.

### **Section 9: Pact Duration**

This pact begins when both parties have legally signed it. It expires for the Contractor 1 month after the payment under the contract, and for all other Bidder 15 days after the contract has been awarded. Any violation of the same would entail disqualification of the bidders and exclusion from future business dealings.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by CEO, TRTI.

#### Section 10: Other Provisions

1. This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal i.e. Pune.

2. Changes and supplements as well as termination notices need to be made in writing. Side

agreements have not been made.

3. Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intentions.

4. Issues like Warranty / Guarantee etc. shall be outside the purview of IEMs.

5. In the event of any contradiction between the Integrity pact and its Annexure, the clause of the Integrity pact will prevail.
