Section- 3: Instructions to Bidders

1. Background of TRTI and introduction to the project

TRTI (TRTI), Pune is an Autonomous Institute of Tribal Development Department; Government of Maharashtra. Purpose of selection of research agencies is conducting research for understanding maternal & child health status of Madia community in Gadchiroli District.



Maharashtra is the 3rd largest state in the country having 43,665 villages out of which 8,428 are tribal villages. According to 2011 census, the tribal population in Maharashtra is 10.5 million which is 9.4% of the total population of the state. This makes Maharashtra the 2nd largest state in terms of tribal population. This data indicates that a significant proportion of the population is tribal and their development is pivotal for overall development of the state. Almost 45 to 50 % of the Scheduled Tribe (ST) population lives in Scheduled Areas. These areas are inaccessible and face lots of challenges in terms of availability of basic amenities which acts as an impediment in the growth and development of the tribal community.

The challenges faced in the Scheduled Areas are mainly in the form of poor physical and network connectivity, electricity shortage, intermittent water supply, absence of transportation services, scarce infrastructure, lack of trained staff to carry out essential services, scarce livelihood opportunities are responsible for socioeconomic backwardness of the tribal communities.

These challenges are further aggravated in case of 3 Particularly Vulnerable Tribal Groups (PVTGs) viz. Katkari in Raigad – Palghar belt, Kolam in Yavatmal – Chandrapur belt and Madia in Gadchiroli district. The unique living conditions in which they are living has a detrimental effect on their health & well-being. However, well documented research targeting PVTGs of Maharashtra is almost non-existent. Therefore, the Commissioner, Tribal Research & Training Institute, Pune is issuing an RFP for '**Selection of research partner for understanding maternal & child health status of Madia community in Gadchiroli district**'.

2. Objectives

- a. To understand the current status of maternal & child health in Madia community of Gadchiroli district.
- b. To gather and analysis disease burden amongst pregnant ladies, lactating mothers and children in the age group of 0 – 6 years belonging to Madia community of Gadchiroli district.
- c. To put forth the factors responsible for the current status of maternal & child health in Madia community of Gadchiroli district.
- d. To suggest corrective measures for improving the current status of maternal & child health in Madia community of Gadchiroli district.



3. Coverage

The research study will conduct stratified cluster sampling targeting 300 villages in 4 blocks of Bhamragad, Etapalli, Aheri and Sironcha. The survey will be conducted on 6000 to 7000 pregnant ladies, lactating mothers and children of these talukas. Summary of talukas wise household population data is mentioned in **Annexure 6.**

4. Scope

4.1. Research proposal: Whilst comparing National Family Health Survey 4th & 5th round, the findings for Gadchiroli district are quite glaring, i.e., Women between the age of 20 – 24 married before the age of 18 years have increased from 8.8% to 10.1%. Further, there has been a stark increase in the women aged 15 – 19 years who were already mothers or were pregnant during the time of survey has increased from 1.5% to 5.1%. Therefore, it is pertinent to note that condition of the Madia community is particularly difficult.

4.2. Therefore, the bidder will have to submit to TRTI, Pune, a research proposal highlighting the research project objectives, work on the indicators pertaining to maternal & child health. The details of the indicators are attached as **Annexure 5.**

4.3. The components of the research proposal are as under:

4.3.1. Submission of abstract (300 words)

4.3.2. Introduction (300 words)

4.3.3. Background & literature review (500 words)

4.3.4. Research questions (200 words)

4.3.5. Aims & Objectives (200 words)

4.3.6. Research Methodology (400 words)

- a. Collection of primary data (type of sampling, reason of using the sampling technique, sample size, etc.)
- b. Analysis of primary data (methodologies & tools to be used must be specified)
- c. Access to secondary data (source of data, how to access that data must be specified)
- d. Analysis of secondary data (methodologies & tools to be used must be specified)
- e. It is important to note that the sample size selected should be stratified cluster random sampling such that equal weightage to each taluka of Gadchiroli district is given equitable weightage. The details of Madia community population is attached as **Annexure 06.**
- f. PO Bhamragad will appoint one officer of the rank of at least TDI (Tribal Development Inspector) with the research team while conducting survey. Similarly, the survey data will have to be certified and authenticated by PO Bhamragad /TRTI before starting data analysis.
- g. The data collected will be in hard copy and digital form.

4.3.7. Expected outcomes (200 words)

- a. Better understanding of the maternal & child health issues faced by Madia community's women in the reproductive age group and children respectively.

- b. Better understanding of the factors responsible for current condition of maternal and child health of the project.
- c. Strategize in improving access to quality health care services for women in the reproductive age group and children belonging to the Madia community.

Note:

- i. The bidder must propose for primary research along with secondary research only.
- ii. The details researcher allowance, travel cost, data collection and analysis should be appended with the research proposal itself.
- iii. The ownership of the raw data so collected and analyses carried out will lie with the TRTI, Pune.

4.4. Submission of interim research paper to TRTI:

The bidder will submit the interim research paper to TRTI for review. The details of findings and analysis will be submitted to the Commissioner, TRTI, Pune for approval.

4.5. Submission of final research report and publication of research papers in peer reviewed or indexed journal:

The bidder will analysis the data collected from the research project and ensure that a final research paper is submitted to the Commissioner, TRTI, Pune. The ownership of the data will lie with the Commissioner office, TRTI. The research paper can be submitted for publication in a peer reviewed or indexed journal **only after clearance from Commissioner, TRTI, Pune**. The details of which and status of its approval are to be submitted to the Commissioner, TRTI, Pune. Further, the bidder shall submit 10 hard copies of the final report to TRTI in English and Marathi each.

5. Bid Process

The Bidder has to submit a Bid on line in **two envelope systems**, one containing **Technical Bid** and other containing **Commercial Bid** for “**RFP For Selection of Research Partner for Understanding Maternal & Child Health Status of Madia Community in Gadchiroli District**”.

The Bidder can submit Bid for conducting research, provided that the Bidder can arrange adequate resources within 7 days of award of contract, to provide Research at the locations for which the Bid is submitted. Failure to arrange the resources, within 7 days, the award of the contract will be cancelled and the EMD will be forfeited.

6. Tender Fee (Non-Refundable)

The Bidders are requested to deposit the **Tender Fee of Rs. 3,000/-** (Online). Proof of the same should be attached with the Technical Bid. It is to be noted that the Tender Fee is non- refundable. However, Tender Fee will be refunded in case of cancellation of overall tender process (i. e, if the tender process is cancelled by TRTI.

7. Earnest Money Deposit

The Earnest Money Deposit (EMD) of Rs. 50,000/- is required to be deposited Online. Proof of the same should be attached with the Technical Bid.

- a. The EMD shall be denominated in Indian Rupees only.
- b. No interest will be payable to the Bidder on the amount of the EMD.
- c. Bids submitted without adequate EMD is liable for rejection.
- d. EMD of unsuccessful Bidders will be refunded after completion of Bid process and the EMD of successful Bidder for conducting research for understanding maternal & child health status of Madia community in Gadchiroli District, will be refunded after submission of the final report to TRTI and allied offices.
- e. EMD shall be non-transferable.
- f. The EMD may be forfeited:
 - i. If a Bidder withdraws his Bid or revises/ increases his quoted prices during the period of Bid validity or its extended period, if any.
 - ii. If successful Bidder fails to sign the Contract within the time specified by TRTI.
 - iii. If during the Bid process, a Bidder indulges in deliberate act that would jeopardize or unnecessarily delay the process of Bid evaluation and finalization. The decision of the TRTI regarding forfeiture of the Bid Security shall be final and binding upon Bidders.

16. Language of Bids

This Bid should be submitted in English language only. If any supporting documents submitted are originally in Marathi or Hindi language, then that will be accepted as it is.

17. Bid Submission Format

The entire proposal shall be submitted strictly as per the format specified in this Bid Document. Bids with deviation from this format are liable for rejection.

18. Submission of Bids

The Bidder should submit the Bid Online, which shall comprise of the following two envelopes (Two envelope systems shall be followed for the Bid):

19. Technical Bid


The Technical Bid should consist of all details, save and except the price as per Annexure- I. Technical Bid should be clearly super scribed as **"Request For Proposal for Selection of Research Partner for Understanding Maternal & Child Health Status of Madia Community in Gadchiroli District"**.

a) Pre-qualification Requirements of the Research Institute is as under:

- i. The bidder must be Registered under Bombay Public Trust Act-1950/Company Act-1956 or 2013/University Grants Commission Act-1956.
- ii. The bidder should have the financial capacity to carry out the Research/Training/Impact Assessment/Evaluation/Relevant project in Govt./Semi-Govt./Autonomous Bodies/PSUs/Private Organization, etc. and therefore to bid, the bidder should have achieved Annual Turnover of equal to or more than **Rs. 15 lakhs** during the last 3 financial years i.e. FY 2017 – 18, FY 2018 – 19 and FY 2019 – 20.
- iii. The bidder must submit audited balance sheet and audited financial statement of FY 2017 – 18, FY 2018 – 19 and FY 2019 – 20. The Income Tax Returns with balance sheet submitted to Income Tax Department.
- iv. The bidder must submit Income Tax Return (ITR) acknowledgment certificate of the Income Tax Department of FY 2017 – 18, FY 2018 – 19 and FY 2019 – 20.
- v. The bidder must have in its name, a valid GST Registration certificate, GST Clearance Certificate up to 31st March 2021 or the latest copy of the GST return certificate.
- vii. The bidder must not have been blacklisted due to malpractice, misconduct, or debarred either by any Government or Central Government Department / Union Territory / Local Authority / Central and Government Undertaking / Government Organizations, for providing emergency medical services, medical screening & patient management through a centralized state of art control room, as on the date of submission of bid.
- viii. The positive net worth certificate by the Chartered Accountant / Registered / Registered Auditor in the last year i.e. FY 2019 – 20/ 2020-21
- ix. The bidder should have Head-office or a regional office located in the state of Maharashtra and it should submit documentary evidence for the same.
- x. **Desirable criteria:** The bidder must have published at least 1 research papers in the field of public health research & epidemiology in peer reviewed or indexed journals.

Note: The Commercial Bid will be opened only after the opening and scrutiny of the Technical Bid. The Commercial Bids of only those Bidders will be opened whose Technical Bids are qualified.

20. Commercial Bid:

The Commercial Bid will contain only the Commercial Bid as per Annexure -II, duly filled in and signed and must be clearly super scribed as **“Commercial Bid for conducting research understanding maternal & child health status of Madia Community in Gadchiroli District”**.

21. Disqualification:

The Bidder should ensure that all the required documents, as mentioned in this RFP / Bidding Document, are submitted along with the Bid. Non submission of the required documents may lead to the rejections of the Bid submitted by the Bidder. Besides other conditions and terms highlighted in the tender document, Bids may be rejected / disqualified under following circumstances:

- In case the Bidder fails to meet the Bidding requirements as indicated in this Bid /RFP or not submitted the Bid in accordance with the procedure and formats prescribed in this document.
- During validity of the Bid, or its extended period, if any, the Bidder increases his quoted price.
- Incomplete Bid or failure to furnish all information required as per tender document and failure to furnish proofs for information provided.
- Bid is received after due date and time.
- Bid is not accompanied by all the requisite documents.
- Bids submitted without or with improper EMD
- Bids without signature of person (s) duly authorized on required pages of the Bid.
- Bids without power of authorization and any other document consisting of adequate proof of the ability of the signatory to bind the Bidder.
- If the information provided by the Bidder is found to be incorrect / misleading at any stage / time during the Tendering Process.
- Technical Bid containing commercial details or revelation of prices in any form or by any reason before opening the Commercial Bid.
- Commercial Bids that do not conform to the Tender's Commercial Bid format (Annexure- II).
- The Bidder not conforming to unconditional acceptance of full responsibility of providing services in accordance with the Agreements of this tender.
- If the Bid does not conform to the timelines indicated in the Bid.
- If the purchaser of the Bid (i.e., who pay Tender Fee and EMD) and submitter of the Bid is different.
- Any effort on the part of a Bidder to influence the Bid evaluation, Bid comparison or contract award decisions by unlawful/corrupt/fraudulent means at any point of time during the Bid process.
- Bidder fails to enter into a Contract within 10 Days of the date of issue of Letter of Selection / Award of Contract or within such extended period, as may be specified by the TRTI.

- While evaluating the proposals (Bids), if it comes to the knowledge of TRTI, expressly or implied, that some Bidders may have colluded in any manner whatsoever or otherwise joined to form an alliance resulting in delaying the processing of proposal, then the Bidders so involved are liable to be disqualified for this contract as well as for a further period of three years from participation in any of the RFP floated by the TRTI.
- Bidder doesn't agree to the any one or more Terms and Conditions of the Bid.

22. Opening of Bid

- Envelope No. 1** containing the **Technical Bid** shall be opened Online in the office of TRTI, in the presence of the Bidder/ representatives of Bidder who choose to attend, at the address, date and time specified in the RFP.
- Envelope No. 2** containing **Commercial Bid** of the Bidders, who have qualified in the Technical Bid, shall only be opened, in the office of TRTI, in the presence of the Bidder/ representatives of Bidder who choose to attend, at the address, date and time specified in the RFP.

23. Evaluation of Technical and Commercial Bid:

Bid Evaluation Committee formed by Commissioner, TRTI will evaluate the Technical and Commercial Bid and submit its recommendation to Commissioner, TRTI. Decision of the Commissioner, TRTI would be final and binding upon all the Bidders.

A. Evaluation of Technical Bid

The evaluation of the Technical Bid will be carried out in the following manner:

- The Bidder's Technical Bid will be evaluated as per the requirements and evaluation criteria as mentioned in this Bid Document. The Bidders are required to submit all required documentation in support of the evaluation criteria.
- At any time during the Bid evaluation process, the Committee may seek written clarifications from the Bidders. The Committee may seek inputs from their professional and technical experts in the evaluation process.
- The Committee reserves the right to do a reference check of the past experience stated by the Bidder. Any feedback received during the reference check shall be taken into account during the Technical evaluation process.
- The technical scores of the Bidders will be announced prior to the opening of the Commercial Bid.
- The Commercial Bid will be opened only after the opening and scrutiny of the Technical Bid. The Commercial Bids of only those Bidders will be opened whose Technical Bids are qualified.

The minimum qualifying marks required in technical criteria is 70 Marks (i.e., 70 %). The Bidders who score minimum 70 Marks shall be considered for Commercial Bid evaluation. The Bidders who do not score minimum qualifying marks of 70 %, their Bids shall be rejected and will not be considered for Commercial Bid evaluation.

24. Award of contract
