Agenda: Pre-bid meeting for the tender: “Expression of Interest (EOI) for Empanelment of Physical Training Cum Coaching Institute for providing Non- Residential Physical Training Cum Coaching for Police, Military, Para Military Examinations for the target group of TRTI & BARTI in Maharashtra” (Tender ID: 2024_TRTIP_1040884_1, dated 12th June 2024). Total 67 bidder’s representatives were present in the Pre-bid meeting.

The pre-bid meeting was organized to address the queries raised by the bidders for the said EOI. The tender is for “Expression of Interest (EOI) for Empanelment of Physical Training Cum Coaching Institute for providing Non- Residential Physical Training Cum Coaching for Police, Military, Para Military Examinations for the target group of TRTI & BARTI in Maharashtra”. The Bid Evaluation Committee clarified the queries point wise raised by the bidder and the same is recorded.
