MINUTES OF PRE-BID MEETING FOR TENDER REFERENCE NO: TRTI/2024/Training-SSC/Desk-4

Agenda: Pre-bid meeting for the tender: "Expression of Interest (EOI) for Empanelment of Coaching Institute for Non- Residential Coaching for Staff Selection Commission's Examinations for Class-III posts for the target group of TRTI, SARTHI and SSC-CGL posts for the target group of MAHAJYOTI in Maharashtra" (Tender ID: 2024_TRTIP_1040800_1, dated 12th June 2024). Total 32 bidder's representatives were present in the Pre-bid meeting.

The pre-bid meeting was organized to address the queries raised by the bidders for the said EOI. The tender is for "Expression of Interest (EOI) for Empanelment of Coaching Institute for Non-Residential Coaching for Staff Selection Commission's Examinations for Class-III posts for the target group of TRTI, SARTHI and SSC-CGL posts for the target group of MAHAJYOTI in Maharashtra". The Bid Evaluation Committee clarified the queries point wise raised by the bidder and the same is recorded.
