Agenda: Pre-bid meeting for the tender: "Expression of Interest (EOI) for Empanelment of Coaching Institute to provide Coaching for Foreign Languages (French, German, Spanish, Korean, Russian and Japanese) for the target group of TRTI in Maharashtra" (Tender ID: 2025_TRTIP_1145532_1, dated 4th February 2025). Total 10 bidder's representatives were present in the Pre-bid meeting.

The pre-bid meeting was organized to address the queries raised by the bidders for the said EOI. The tender is for "Expression of Interest (EOI) for Empanelment of Coaching Institute to provide Coaching for Foreign Languages (French, German, Spanish, Korean, Russian and Japanese) for the target group of TRTI in Maharashtra". The Bid Evaluation Committee clarified the queries point wise raised by the bidder and the same is recorded. The queries received by bidder's representatives with Bid Evaluation Committee remarks are placed as below. The Bid Evaluation Committee has also decided that the pre-bid meeting minutes should be treated as part of the EOI conditions and shall be binding to Bidders.

Bidder must have submit "Self-Delectation on their letter head" by mentioning in which Foreign Languages (French, German, Spanish, Korean, Russian and Japanese) they are going to participate.
3	Other	Other	What will be the shortfall documents calling process?	Since, Published EOI is a Single Bid system OR Single Cover Tender – (Technical Bid ONLY). Therefore, Shortfall documents will be called from bidder by their provided "Email Id" in the submitted bid document/s ONLY. Hence, bidder are requested to correct their "Email Id" in mahatender website login.

It was also decided that the queries received after the deadline as per EOI & after pre-bid meeting, shall not be considered for reply and e- tender bidding. The meeting ended with a vote of thanks.
