2.1 About Tribal Research & Training Institute

The Tribal Research & Training Institute (TRTI) was established in May 1962 to undertake research studies on various aspects of tribal and to assess the impact of developmental programs / schemes on the life of the tribal people. In order to strengthen the capacity of the TRTI to achieve the objectives, the Government of Maharashtra (G.R. No. TRT-2013/F. No. 787/D-5/Date 24/12/2013) has decided to give it a Status as an Autonomous Association / Society under the Societies Registration Act and Bombay Public Trust Act. It has a tribal museum, which creates an outreach environment from within the museum to the outside world so that curiosity and wonder is stimulated about the tribal.

2.2 About RFQ Background

Tribal Research and Training Institute, Maharashtra State, Pune is an autonomous organization of the Government of Maharashtra, which was established under the centrally sponsored scheme in 1962. Tribal research and training institutions are working in the tribal-dominated states of the country to conduct research on various aspects of tribal subjects.

The following objectives of the organization were set up during the establishment of this institution. Organization's Objectives and Functions

- 1. Evaluate the impact of various schemes implemented by the Central and State Government for the financial, educational and social development of tribal communities on tribal life.
- 2. Do research on issues related to tribal life and development.
- 3. Providing pre-employment training for the officers / employees working in Tribal Development Department and for tribal students.
- 4. Organizing different training sessions for the tribal
- 5. Adivasi cultural museum to organize tribal arts and culture, organize handicraft exhibition in different urban areas, and create a short film on tribal life.
- 6. Administrative control over the functioning of Scheduled Tribes Certificate Verification Committees working in the State level in Maharashtra State
